

# Artist Agreement

**Deadly Music**

This agreement is between:

## 1. What This Agreement Is About

This agreement explains how we'll work together to sell and promote your music and merchandise through [www.deadlymusic.co.uk](http://www.deadlymusic.co.uk).

It's a non-exclusive agreement - you're free to work with others too.

## 2. Your Rights

You keep full ownership of your music, artwork, and merch designs.

You give Deadly Music permission to:

- Sell your music , tickets and merch on our website
- Promote those products for sales purposes

Nothing else changes about your ownership.

### 3. Deadly Music's Fee

Deadly Music takes a 10% fee on:

- Merchandise sales
- Music sales

And a fixed fee of 20p on ticket sales

Only for sales made through or via [www.deadlymusic.co.uk](http://www.deadlymusic.co.uk). Or via our social media channels.

That's it - no hidden extras

### 4. Card & Payment Fees

Any payment processing fees (for example Stripe, PayPal, Mollie, card fees) are:

- Taken out of the sale amount first
- Deducted before your profit is calculated

These fees are part of making the sale and aren't covered by Deadly Music.

### 5. How Your Earnings Are Worked Out

Each sale is calculated like this:

1. Sale price
2. Minus card / payment processing fees
3. Minus Deadly Music's 10% fee
4. What's left is your profit.

---

## 6. Paying You

- Payments will be made **monthly**
- Paid via **bank transfer**
- You'll make sure your payment details are correct

If there's a delay caused by incorrect details, that's not on us.

---

## 7. Taxes

You're responsible for handling your own taxes, VAT, or reporting income from sales.

Deadly Music doesn't give tax advice.

---

## 8. Promises We Both Make

You confirm that:

- You own or control the rights to the music and merch
- Your content doesn't infringe on anyone else's rights
- You're allowed to enter into this agreement

If any issues come up because of this, you agree to cover Deadly Music from related claims.

---

## **9. Ending the Agreement**

Either of us can end this agreement by giving **14 days' written notice**.

We can also end it immediately if there's a serious breach of trust or terms.

Once ended:

- We'll stop selling your products
- Any outstanding payments will be settled properly

---

## **10. Liability**

Deadly Music isn't responsible for indirect losses or missed profits beyond what's earned under this agreement.

Nothing here removes responsibility for fraud or negligence where the law doesn't allow it.

---

## **11. Keeping Things Confidential**

We both agree not to share private business or financial info unless required by law.

---

## 12. Legal Stuff

This agreement is governed by the laws of **England and Wales**, and any disputes will be handled there.

## 13. The Full Agreement

This document is the full agreement between us. Any changes need to be agreed in writing by both sides.
